GLOSSARY:

"**Featured Entertainment**," means the playing of sound recordings & music videos as the main feature of entertainment and includes music for entertainment, product launches, dancing, karaoke singing and entertainment provided by disc jockeys.

"**Non-featured Entertainment**" means the playing of sound recordings or music videos where it is not the main feature of entertainment, e.g. Background piped-in music including Radio/TV broadcasts.

"**Traditional Coffee Shop**" means non air-conditioned commercial premises where its coffee, tea or other beverages are sold at non-premium prices and includes a restaurant that does not cater for wedding or birthday functions within its premises.

Category 1: Single Event/Concert/Showcase

- (a) **Featured Entertainment**
i) Per Day / Per Venue
 1st 50 persons - RM250
 Every additional person - RM1 per person
ii) Per Annum
 Unlimited single events - RM25,000 per annum per concourse/stage/ballroom/premises etc.
- (b) **Non-featured Entertainment**
i) Per Day / Per Venue
 Flat rate of RM 250 per event -
ii) Per Annum
 Unlimited single events - RM7,200 per annum per ballroom/function room.
- (c) **Commercial Rental Licence (See definition at Category 17)**
 Flat rate of RM 250 per day - excluding public performance
- (d) **Concert & Showcases**
 i) Featured entertainment (i.e. Dancing or Singing with "Minus-one", Live Dj sets, stage shows)
 RM 1.00 per person *Subject to a min of RM1,000 or a max of RM 10,000 per day
 ii) Non-featured entertainment (i.e. Background or piped-in music including diffusion of Radio / TV music) - Flat rate of RM1,000 per day

Category 2: Establishment with Featured Entertainment

(e.g. Discotheque, Karaoke, Dangdut, Nightclub, Fun Pub, Lounge, Bistro, Caf , etc.)

Category 3: Hotel *(per annum)

(Non-featured Entertainment)

- (a) RM 15 per guest room
 (Sound Recordings including Radio broadcasts)
 (b) RM 15 per TV per guest room
 (Music Videos including TV broadcasts)

*Separate charges apply for other individual outlets within Hotel premises.

Category 4: Office/Shopping Complex/Supermarket/Car Park/Retail Shop/Departmental Store/Bank/Hi-Fi Shop/Car Accessories Shop/Showroom

(Non-featured Entertainment)

- First 2,000 sq. ft - RM 600 per annum
 Additional sq. ft - 9.3 ¢ per sq. ft. per annum
 (RM 1 per sq meter)
 Surcharge applies - see Category 15(b),(d) & (e)

Category 5: Cinema/Recreation Centre*/Service Station/Workshop/Hairdressing Saloon/Video Arcade/Snooker Centre/Bowling Alley

(Non-featured Entertainment)

(e.g. Health Centre & Spa (other than hotel premises), Dance Studio, Aerobics Centre, Music/Dancing School, Skating Rink, Cineplex, Fitness Centre, etc)

- Flat rate - RM 600 per annum
 Surcharge applies - see Category 15(b) , (d) & (e)

Category 6: Bar/Lounge/Pub/Caf /Beer Garden*/Spa/Health Centre

(Non-featured Entertainment)

- First 50 persons - RM 1,200 per annum
 Every additional person - RM 10 per person per annum
 Surcharge applies - see Category 15(a) , (d) & (e)

*Within Hotel premises

Category 7: Restaurant/Cyber Caf /Food Court

(Non-featured Entertainment)

- First 100 seats - RM 600 per annum
 Every additional seats - RM 2 per seats per annum
 Surcharge applies - see Category 15(b) & (d)

Category 8: Telephone Switchboard

(Music - on hold only)

- RM 600 per switchboard per annum for 1st 10 lines
 Every additional line @ RM 10 per annum

Category 9: Amusement/Pleasure/Theme Park

(Non-featured Entertainment)

- RM 100 per speaker per annum* (Open area only)
 * subject to a minimum of RM 600 per annum.
 separate charges apply for other individual outlets within the park.

Category 10: Public Transport : Bus, Coach, Boat, Ferry, Limousine

(Non-featured Entertainment)

- RM 100 per vehicle per annum
 Surcharge applies - see Category 15(c) & (e)

Category 11: Traditional Coffee Shop (see Glossary above*)

(Non-featured Entertainment)

- 1st TV / Audio Player - RM 300 per annum
 2nd or subsequent TV - RM 100 per TV p.a.
 - surcharge applies - See Category 15(d) & (e)

Category 12: Member Clubs/Trade Associations

(Non-featured Entertainment)

- RM 600 per annum for common area only.
 *Separate charges apply for individual outlets within the club premises (e.g. Disco, Karaoke, Restaurant, Pub, Lounge, Shop etc)
 Surcharge applies - see Category 15(b),(d) & (e)

Category 13: Exhibition Hall/Centre

(Non-featured Entertainment)

- (a) RM 250 per day for the whole hall/centre
 (b) i. RM 25 per day per individual stand/booth (not exceeding 100sq.ft)
 ii. RM250 per day per individual stand/booth (exceeding 100sq.ft)

Category 14: Medical Centre, Hospital & Clinic

(Non-featured Entertainment)

- (a) Reception/Consultation area - RM 300 per annum per area
 Surcharge applies - see Category 15(b)
 (b) Room for patients - RM 15 per room per annum

Category 15: TV Monitor Surcharge

(Non-featured Entertainment)

- (a) RM 400 per monitor per annum (for Category 6 only)
 (b) RM 200 per monitor per annum (for all except Category 6)
 (c) RM 100 per monitor per annum (for Category 10 only)
 (d) RM 1,000 per video wall/Multiple Screens per annum
 (Screen size of 6 ft. & above - for all categories)
 (e) RM1000 per annum for karaoke facility

Category 16: Factory, Industrial Premises & Associated Offices

(Non-featured Entertainment)

- RM 5.00 per employee per annum.
 Minimum Rate : RM 600 per annum
 Surcharge applies - see Category 15 (b),(d) & (e)

Category 17: Commercial Rental Licence (Excluding Public Performance)

(i) **Mobile Operator (e.g. Djs, Emcees, Music Equipment Suppliers, Event Managers, etc).**

License for renting sound recordings, music videos and / or Karaoke to third parties as part of Licensee's business or commercial activities.

- A Licence - RM 3,000 per annum
 B Licence (Excluding performances at Hotel Ballrooms/Public Halls/Complexes) - RM1,200 per annum

(ii) **Jukebox Operator**

License for renting jukeboxes as part of Licensee's business or commercial activities - RM 120 per jukebox per annum

Category 18: Computerised Karaoke on Demand Juke Boxes (Public Performance Licence Only)

- First 5 units of Juke Boxes - RM 2,000 per annum
 Subsequent units of Juke Box - RM360 per juke box per annum

 3) PPM Board of Directors shall decide the classification of any establishment.

“重點娛樂”(Featured Entertainment)既是播放錄音制品或音樂錄影以作為主要的娛樂，並包括娛樂性音樂，產品推介禮，舞蹈，卡拉OK 歌唱和音樂騎師(DJ)所播放的娛樂項目。

“非重點娛樂”(Non-Featured Entertainment)既是播放錄音制品或音樂錄影，並不是以娛樂為主，例如電台或電視廣播的背景音樂。

“傳統式咖啡店”即無冷氣設備之商店，無額外價格銷售其咖啡，茶或其他飲料，包括那些沒有承接婚宴或生日慶典用途的餐廳。
